

Example with 2 World Top companies






Ongoing Commercial Disputes

• Billions of dollars in **Damages Claimed**

- How Disputes are resolved?
 - **≻**Court
 - ➤ Alternative Dispute Resolution (ADR)
 - Arbitration
 - Mediation

Agri-commodity





World Wheat Trade (USDA): + 26%

- Yearly Average 10/12 = 141 MMT
- Yearly Average 16/18 = 179 MMT

Ukraine + Russia WHEAT Exports: + 91%

- Yearly Average 2009 + 2011 = 27.5 MMT
- Yearly Average 2017+2018 = 52.5 MMT

What is Mediation?



- A Structured & Interactive process <u>facilitated</u> by a Mediator.
- The Mediator:
 - Enables the Parties to communicate and build a solution together.
 - ➤ Is Neutral & Independent
- Confidential
- Voluntary Process
- <u>Settlement Agreement</u>



Advantages of Mediations

TERRAXIS

- Fast Process & Low Cost
 - ➤ 1 meeting up to several meetings: matter of days
 - ➤ Gafta Arbitration 2017/2018 = 7 months (if Appeal: +11, total 18 months)
 - > Court: several years
- Parties create their solution

Preserve relationship





Success rate: Approx. 70%

When is it not appropriate? TERRÁ




- The need to establish a legal precedent
- Serious imbalance between the parties
- Incompetence/Bad Faith the counterpart
